Back again this year at Inali North Day Camp, we are offering a Tot Lot for siblings not yet old enough to attend camp or other summer time events!

Tot Lot is intended for the use of Parents attending Day Camp as Staff or as Day Walkers. It will be offered daily Monday through Thursday the week of camp from 8:45am to 3:00pm. On Friday, Family Day, the Tots will travel with their Family.

Tot Lot will open Daily at 8:45am; participants will rejoin their parents for lunch at 11:25am at the lunch area and then sit with them during our daily after lunch presentation. At 12:40, after the presentation participants will return to the Tot Lot until the closing ceremony at 3:00pm.

Tot lot participants will participate in a program designed for their age group, including arts and crafts, games, stories, water fun, and even a chance to be part of a skit on Family Day.

The camp will provide cold drinking water; it will be the parent's responsibility to provide juice and an approved snack for the morning and afternoon break times. Parents will also need to provide lunch for their Tots and should keep that with their pack cooler. The camp will have a cooler available at the Tot Lot area for drinks and snacks. Participants may be contacted by the Tot Lot Director prior to camp with further instructions about snacks and drinks.

All participants will need to have a Tot Lot Application turned in by May 9th, and a Medical Form A & B turned in at check-in (along with the Unit's they are associated with). Please submit your information to your Pack Coordinator in time that it may make this dead line.

The Cost of this Tot Lot is Free, but may only be used for the children of Staff and Day Walkers.

Participants must be at least 3 years of age and potty trained; no diaper or pant changing is allowed at camp. Participants should be able to accept being left at the Tot Lot during Camp hours; parents will be called to deal with tantrums.

The goal of this Tot Lot is to offer an opportunity for Scouts and Adults to attend Day Camp who would otherwise face the hardship of Babysitting fees.
